According to Equal Employment Opportunity Commission, overall EEOC charge filings increased **9.2**% from **2023** to **2024**.3



Claims are relatively equally distributed between Employment Practices and Directors & Officers claims. Common EPL claims involve allegations of retaliation, wrongful termination, as well as race, disability, pregnancy & age discrimination. Common D&O claims involve breach of contract claims, breach of fiduciary duty and board mismanagement.<sup>4</sup>
